STORMWATER SYSTEM

Stormwater is the water from rain and irrigation which flows over ground or pavement without soaking into the ground.


The stormwater drainage system includes roadside swales, ditches, retention ponds, gutters, inlets, catch basins and underground pipes that collect stormwater and carry it away from streets, parking lots and vards.

Stormwater can flow into lakes, ponds and the Indian River Lagoon. So, our waterways are part of the stormwater drainage system too.



DID YOU KNOW that anything that is washed into the stormwater drainage system ends up in our waterways? Unlike wastewater from kitchens and bathrooms. stormwater is not treated before it enters these precious waters.

POINTLESS PERSONAL POLLUTION



Discharges from *boint sources*, such as industry or sewage treatment, that flow through pipes and into our water bodies, can be readily identified and treated.

Point-less source pollution, commonly referred to as stormwater runoff, is more difficult to identify and treat because our personal activities can cause it and then it travels to ground and surface waters via a variety of pathways.

POINTLESS PERSONAL POLLUTION IMPACTS OUR WATERS

Pointless Personal Pollution comes in many forms that contaminate our waters. Nutrients from fertilizers, septic tanks and animal waste cause excessive growth of algae and aquatic weeds. Garbage and litter reduce the oxygen in the water which can kill the aquatic life. Heavy metals and pesticides can kill aquatic organisms and contaminate ground water.

Look around your home, yard and workplace for pollutants that could end up in local waterways, such as oil & grease from auto or lawn equipment, pesticides, fertilizers, weed killer, litter, pet waste, yard clippings or sand and dirt from erosion.

REDUCE POINTLESS PERSONAL POLLUTION

- Shop for products labeled biodegradable, non-toxic, non-phosphorus or water soluble. These products readily decompose and will not pollute surface or ground water.
- Compost leaves, grass and clippings. Then, use compost as mulch to supplement fertilizers. When using compost you are returning nutrients back to the soil and will require less fertilizer use.
- Do not apply lawn chemicals if rain is in the forecast. This prevents excessive wash off into waters.
- Keep toxic products in a safe storage area, in original containers and clearly marked.
- Service your vehicle regularly to help prevent motor oil, anti-freeze or other toxic fluids from leaking onto the ground/road and washed into waterways.

CONTAIN YARD WASTE

Edgewater's Refuse Department works hard to remove items and yard waste placed by the road. We encourage residents to bag or contain yard waste as much as possible.



Picking up individual piles of sticks and other small vegetative items is time consuming and slows down the operation. However, if you put those items in a container that can be picked up and emptied into garbage trucks, it greatly improves our ability to provide timely service.

While uncontained piles of vegetative debris are picked up on a continual route, we commit to picking up all bagged and contained yard waste each week. So remember, if you can contain it, we can take it...every week.

Florida has a curbside recycling problem. Floridians are contaminating curbside recycling bins with materials that are not meant to be ther — mainly plastic bags; tanglers, like cords and hoses; and clothing. 3 Let's **RETHINK** what we recycle and **RESET** our behavior to focus on recycling the *basics* at curbside. **Back To The Basics** Aluminum Plastic & Steel Cans **Bottles & lugs** When in doubt - throw it out!
