PUBLIC NOTICE OF PROPOSED CDBG DISASTER RECOVERY MITIGATION INFRASTRUCTURE PROJECTS FOR THE CITY OF EDGEWATER

The City of Edgewater anticipates applying for Round Two of the Rebuild Florida General Infrastructure Program (GIP) funding provided by the U.S. Department of Housing and Urban Development (HUD) to support long-term mitigation efforts by assisting the State of Florida and its local governments in minimizing or eliminating the risks and reducing losses from future disasters. This program is being administered by the Florida Department of Economic Opportunity (DEO) thru the Community Development Block Grant – Mitigation (CDBG-MIT) Program. A total of four hundred seventy-five million dollars (\$475,000,000.00) in funding has been allocated by the Florida Department of Economic Opportunity (DEO) for the Rebuild Florida General Infrastructure Program. The funding will be allocated through three separate funding cycles which will be held over a three-year period with the second funding cycle, to have applications due into DEO on or before September 17, 2021. The amount of funding available in the second GIP application cycle is one hundred seventy-five million dollars (\$175,000,000.00). The minimum allowable grant request is two million dollars (\$2,000,000.00). Eligible types of projects are those that demonstrate increased community resiliency. Examples of some of the types of projects encouraged by DEO are as follows:

- Restoration of critical infrastructure (such as water and sewer facilities, streets, removal of debris, drainage, bridges, etc.).
- Renourishment of protective coastal dune systems and state beaches.
- Building or fortifying buildings that are essential to the health, safety and welfare of a community (this can include police stations, fire stations, parks and recreational centers, community and senior centers, hospitals, clinics, schools and educational facilities, other public properties).
- Rehabilitation or construction of stormwater management systems.
- Improvements to drainage facilities.
- Reconstruction of lift stations and sewage treatment plants.
- Road repair and improvement and bridge strengthening.

The City of Edgewater anticipates submitting one application for a total of fourteen million, thirty-three thousand eight hundred ninety-four dollars (\$14,033,894.00) in funding through Round Two of the CDBG-GIP General Infrastructure Program.

Activities that are typically eligible for funding under the Community Development Block Grant (CDBG) Program as well as specific additional activities as outlined in the State of Florida CDBG-MIT Action Plan for the program are eligible projects if no other funding is available to meet the need. Applications are due in DEO no later than September 17, 2021.

In this application the City of Edgewater proposes to upgrade the oldest portion of the City's Sanitary Sewer Collection System which was installed in the 1960's and to hook-up approximately sixty (60) households currently on septic tanks to the City's central sewer system.

The City of Edgewater anticipates submitting an application for funding to hook-up approximately sixty (60) households currently on septic tanks to the City's Sanitary Sewer Collection System. Additionally, the project will include the reconstruction of two lift stations, the lining of 265 existing brick manholes, the lining of 30,000 LF of eight-inch (8") VCP Sewer Lines and the lining of thirteen hundred (1,300) LF of Sanitary Sewer Service Laterals.
