## GOVERNMENT

The City of Edgewater was incorporated as a municipality in 1951 and has a Council/Manager system of government. The City Council has 4 members and a Mayor, chosen at large, who is the 5th member and presiding officer. Councilmembers serve for 4 year staggered terms.

The City Council enacts all ordinances and resolutions, including the Comprehensive Plan and land development regulations; and adopts the City budget. The Council appoints the City Manager, City Attorney, City Clerk, all of who report directly to the City Council. The City Council also appoints the members of all advisory Boards and Committees .

City Council meetings are held at least once each month on the 1<sup>st</sup> Monday of the month at 6:00 p.m. in the Council Chambers located at 104 N. Riverside Drive .

City Hall is located at 104 North Riverside Drive and is open from 8:00 a.m. to 4:30 p.m. weekdays.

## DEPARTMENTS

### CITY MANAGER

The City Manager is Edgewater's Chief Executive Officer and is responsible for the management of all the City's policies, financial affairs, City Staff and operations. This includes the City's annual operating budget and all projects and purchases funded in the budget.

### CITY CLERK

The City Clerk maintains and records all official documents of the City and its public bodies. The Clerk attends all City Council meetings and maintains accurate records of all Council proceedings. The Clerk is responsible for processing public record requests, minutes, agreements & contracts, alarm program and all City elections.

### CITY ATTORNEY

The City Attorney is chief legal advisor and attorney for the City Council, City Manager, City Clerk and all City departments, boards and agencies.

### FINANCE DEPARTMENT

The Finance Department provides financial management and policy support and financial information to the City Manager, departments, the public and other agencies. Finance Administration oversees the administrative and financial affairs of the city including accounting, budget, purchasing, payroll, accounts payable, accounts receivable, issuance of business tax receipts, utility customer service and information technology support.

### PARKS & RECREATION DEPARTMENT

The Parks & Recreation Department maintains the City's system of parks, coordinates recreation programs with the YMCA, maintains recreation facilities used by residents, maintains median strips on U.S. 1 and Indian River Boulevard, and coordinates the EDGEfest special event series. The Department also maintains and repairs all City owned buildings and facilities. The Parks & Recreation Department is located at 1108 S. Ridgewood Avenue.

### HUMAN RESOURCES

The Human Resources Department accepts applications for employment with the City. They also assist in developing and maintaining policies, procedures and benefit programs for City employees.

### DEVELOPMENT SERVICES DEPARTMENT

The Development Services Department consists of the Planning & Zoning and Building Divisions.

- **PLANNING & ZONING DIVISION**

The Planning & Zoning Division monitors and revises the Comprehensive Plan, reviews site plans, performs directed research, processes all applications for development, including land use changes, annexation, special activity permits and variances.

- **BUILDING DIVISION**

The Building Division issues permits required for all renovation work and new construction. They examine drawings, make inspections and issue certificates of occupancy. This division ensures that all construction is done in accordance with the Florida Building Code and local adopted codes. City regulations are very specific regarding various kinds of construction. Please call the Building Division for information on regulations, permit requirements or to find out if a contractor is licensed to work within the City.

### POLICE DEPARTMENT

The Police Department provides a safe and secure environment for people in our community. The department is comprised of 34 sworn police officers and 5 civilian support staff. The Police Department is committed to providing the highest quality of service to all citizens.

### EDGEWATER POLICE VOLUNTEERS ASSOCIATION (EPVA)

The Edgewater Police Volunteers Association is a non-profit organization that assists the Police Department with volunteers to perform neighborhood and business security patrols, vacation house watches, and assisting in special events with crowd and traffic control.

## DEPARTMENTS (CONTINUED)

### ENVIRONMENTAL SERVICES

The Environmental Services Department has several divisions:

- **THE WATER PLANT** is capable of producing 5 million gallons per day of potable water.
- **THE WASTEWATER PLANT** has a sewage treatment capacity of 2.75 million gallons per day.
- **THE WASTEWATER COLLECTIONS DIVISION** maintains and repairs all wastewater lift stations throughout the City. These personnel also assist Field Operations for sewer line repairs.
- **THE FIELD OPERATIONS DIVISION** provides customer service assistance by reading meters, performing leak checks and they install new water, sewer, and reclaim connections, complete required maintenance and repairs and other various utility work.
- **THE STREET DIVISION** maintains all City roads and right-of-way including mowing, trimming of trees, grading of shell roads and repairing of pot holes. The Street Division also maintains inventory and maintenance of all signs within the City.
- **THE REFUSE DIVISION** picks up garbage twice a week and bagged lawn trimmings on Wednesdays. The City's outside contractor, Southard's Recycling, picks up recyclables once a week.
- **THE STORMWATER DIVISION** is responsible for the maintenance of the swales, retention ponds, canals and lakes within the City and to process stormwater permits for construction.
- **THE FLEET MAINTENANCE DIVISION** is responsible for all repairs and maintenance on City owned vehicles and equipment.

## FIRE/RESCUE

The Fire/Rescue Department has several divisions:

- **THE FIRE/RESCUE & LIFE SAFETY DIVISION** consists of 31 career and approximately 3 volunteer members. The department is a licensed advanced life support provider with paramedic/firefighters on duty 24 hours per day at each of the City's two fire stations.
- The department also provides fire suppression, fire prevention, ambulance transport services, public education, inspection, emergency preparedness and safety services to the City. Emergency Management falls under the direction of the Fire Chief
- **THE CODE ENFORCEMENT DIVISION** enforces the City codes by making inspections and referring violations to the Special Magistrate for action. The Code Enforcement Division is located at 1605 S. Ridgewood Avenue.
- **THE ANIMAL CONTROL DIVISION** is also under the direction of the Fire Chief
- **EDGEWATER ANIMAL SHELTER** is currently under the operation of Kayla Kurtz, DVM. The Animal Shelter is located at 605 Mango Tree Drive.

## ADVISORY BOARDS & COMMITTEES

### FIREFIGHTERS PENSION BOARD

This Board determines retirement trust fund systems and plans are administered in such manner as to maximize protection of firefighters' retirement. Meets 4 times a year in the Council Chambers.

### GENERAL EMPLOYEES PENSION BOARD

This Board reviews investment funds, benefits and determines financial stability. Meets 4 times a year in the Council Chambers.

### ECONOMIC DEVELOPMENT BOARD

This Board formulates plans for use and development of property for industrial development and promotes the City as a prospective site for industry. Meets the first Wednesday of the month at 8:00 a.m. in the Council Chambers.

### PLANNING AND ZONING BOARD

This Board is responsible for implementation of the Comprehensive Plan and Land Development Code with recommendations to be made to Council. They hear applications for annexations, variances to the Land Development Code, review Comprehensive Plan Amendments and review rezoning requests and Conditional Use Permit requests. Meets the second Wednesday of the month at 6:30 p.m. in the Council Chambers.

### RECREATION AND CULTURAL SERVICES BOARD

The Recreation and Cultural Services Board studies recreation needs and advises the Council regarding the maintenance and operation of parks. This Board also advises on beautification and historical matters. Meets quarterly on the 2nd Thursday at 5:00 p.m. in the Council Chambers.

### POLICE PENSION BOARD

This Police Pension Board oversees the police officer retirement trust fund system and associated investment plans. The Police Pension Board meets 4 times per year in the City Council Chambers.

### SPECIAL MAGISTRATE

The purpose of the Special Magistrate is to provide equitable, expeditious, effective, and inexpensive methods of enforcing the technical codes and ordinances of the City. Hearings, if needed, are scheduled for the second Thursday of the month at 2:00 p.m. in the Council Chambers.

## PARKS & FACILITIES

**WHISTLE STOP PARK** - Located on Roberts Road adjacent to the railroad tracks. Facilities include racquetball courts, tennis courts, restrooms, pavilions, dog park, lighted ballfields, playground equipment, a basketball court, fitness trail, splash park, volleyball court, skateboard park and a greenspace for future farmer's markets.

**MENARD MAY PARK** - Located on Riverside Drive and Ocean Avenue on the Indian River. Facilities include playground equipment, volleyball court, restrooms, pavilion, picnic tables, grills, fishing pier, kayak launching facility and natural boat launch.

**GEORGE KENNEDY MEMORIAL PARK** - Located on Riverside Drive across from City Hall, on the Indian River. Facilities include 4 boat ramps, and a fishing pier with gazebo and restrooms.

**VETERANS PARK** - Located on the Indian River at the Indian River Blvd. and Riverside Drive intersection. Facilities include restrooms, a fishing pier and picnic area.

**ROTARY PARK** - Located on West Park Avenue and Carol Ann Drive. Facilities include a Dog Park, gazebo, pavilion, restrooms, playground equipment and a full basketball court. Rotary Park is also the trail head to the County's East Regional Rail Trail which is part of the St. Johns' River to Sea Loop which encompasses 5 counties in Florida.

**UMBRELLA TREE PARK** - Located at 15th and Umbrella Tree Drive in Florida Shores. Facilities include 2 swingsets and a half basketball court.

**LAKE & ALICE PARK** - A small park located on the corner of Lake Avenue and Alice street. Facilities include 2 swing sets a picnic table, Global Motion, bench, shade structure, bike rack and trash receptacle

**DUCK LAKE PARK** - Located at 16th and Mango Tree Drive in Florida Shores. This park has a lake for fishing. You're bound to see plenty of ducks!

**HIGHLAND SHORES PARK** - Located on the eastern side of Riverside Drive between River View Drive and Dixwood Avenue. This is a natural area along the river with a lovely gazebo.

**RIVERWALK** - A handicap accessible walkway that connects 5 parks with river access along the length of riverside drive by the Indian River with



benches and a gazebo. (3.3 MILES) Including 9 fitness stations

**HAWKS PARK RECREATION COMPLEX** – Located at 1108 S. Ridgewood Avenue. 44-acre site that facilitates a 19,000 sq. ft. recreation complex with heated pool, operated by the YMCA. Baseball field complex (4 lighted fields), soccer complex (3 lighted fields), nature area with handicap accessible trail, conservation area, outdoor amphitheater, administration office, museum and Parks & Recreation Maintenance Building.

**EDGEWATER LIBRARY** - Operated by Volusia County. Located at 103 Indian River Boulevard. A library card is issued free to all Volusia County residents and a \$30.00 charge for all non-residents. Please bring proof of residency when applying for a card. The Library presently has over 25,000 volumes of books, a video cassette collection, DVD's/CD's and Videos, computers and photocopiers for public use and a children's department with a variety of children's programs. Library 386-424-2916

**RECREATION PROGRAMS** - Edgewater presently sponsors programs in Sr. Over 55 softball. For more information on programs and sign up times, contact the Edgewater Parks & Recreation Dept. Other programs are available through the YMCA in conjunction with the Parks & Recreation Dept.

**EDGEWATER COUNCIL CHAMBERS** - Located next to the City Hall Building on Riverside Drive. This facility is used for Council meetings and Board meetings.

**YMCA** – Located at 148 W. Turgot Avenue off Ridgewood Avenue. This complex operated by the YMCA includes a fitness center, aerobics room, large gymnasium with lockers, a teen/senior room and a heated pool. The YMCA provides a wide variety of programs for both youth and adults. For more information, call 386-409-9622.

**HISTORICAL MUSEUM** – Located at 1108 S. Ridgewood Avenue in the Parks & Recreation Department Office. The museum has historical items that have been donated to the

City.

## SOLID WASTE PICK UP INFORMATION

### GARBAGE/HOUSEHOLD

Twice per week - Monday/Thursday or Tuesday/Friday.

Residents are encouraged to place all household refuse in the city-provided carts.

The City will provide one (1) cart with up to 95-gallon capacity. Additional carts will be provided for a one-time \$35.00 administrative charge, with an additional \$5.00 monthly collection fee.

### RECYCLING

Once weekly on one of your regular garbage pickup days. Collected by Southard's Recycling 386-426-8858

### YARD TRASH - BAGGED OR CONTAINED

Once weekly on Wednesdays. All leaves, pine needles, clippings, palm fronds, etc. should be placed in your City provided cart, or bagged for pickup. Up to eight (8) bags of yard waste will be accepted a week in addition to your cart. There will be no pickup of bagged yard waste on holiday weeks except for Thanksgiving week.

### YARD TRASH—LOOSE LAYING

Yard waste/brush (i.e., loose laying) piles should be placed at the curbside in front of your home. Loose-laying yard debris is picked up on a continuous route. If your loose-laying brush pile is at curbside for longer than a week, please call the Environmental Services Department Customer Service line at 386-424-2400 x4007.

Yard waste or brush piles exceeding a combined volume of 4 feet by 4 feet by 4 feet will incur an additional pickup fee.

All yard waste/brush generated by a contractor must be disposed of by the contractor.

### **TIRES**

Four (4) per residential household at no charge per Commercial tire pickup to be charged to business dependent on quantity/size of tires. Year

### **HOUSEHOLD APPLIANCES/FURNITURE**

Appliances & other metal goods should be set out with your normal garbage. If item is too large for pick up, another truck will come by and get it.

Furniture & carpet should be put out on Wednesdays to be picked up with your yard trash.

## SOLID WASTE PICK UP INFORMATION

### \* \* CAUTION \* \*

When you place your garbage and residential waste out for the twice weekly collection make sure there is nothing adjacent to the items to be collected that you may want to keep.

Our Refuse Department employees pride themselves on the job they do and anything close to the cans and bags to be collected will probably be collected also.

The Refuse Department starts their daily collection at 7:00 a.m. Monday—Friday, so please make sure your garbage is by the edge of the road by 7:00 a.m., as routes sometimes change.

### LOCATION OF GARBAGE CONTAINERS

Garbage and trash containers when not in use shall be kept away from the front of any building or premises. Garbage and trash containers may be placed in front of the building or premises the evening before the scheduled pick-up service.

All garbage and trash containers shall be removed from the front of any building or premises receiving garbage and trash pick-up not later than 11:00 p.m. of the day of the scheduled pick-up.

Due to environmental regulations, the City cannot handle the disposal of any paint or hazardous material at the City Public Works Facility. All material must be disposed of at the Volusia County Landfill located at 1990 Tomoka Farms Road, Port Orange. Volusia County provides a non-commercial paint exchange facility where residents may trade-in unwanted paint for a different color or type. Contact the Volusia County Landfill for more information at 386-947-2952. Hazardous Waste items are free to dispose of at the landfill.

Hypodermic and IV needles CANNOT be placed in your garbage. "Sharps" disposal container information may be obtained at the following locations:

## SOLID WASTE PICK UP INFORMATION

### HOUSEHOLD BATTERY RECYCLING

Volusia County residents can recycle their old household batteries at the Volusia County Landfill. Any type of batteries, except automobile, are accepted.

### EDGEWATER CURBSIDE RECYCLING

The City of Edgewater would like to encourage each resident to recycle.

## EDGEWATER UTILITY ACCOUNTS WATER, SEWER, REFUSE & STORM WATER

### ESTABLISHING UTILITY SERVICES

The City of Edgewater requires a utility deposit of up to \$200 (based on soft credit check) and a \$35 service fee before water, sewer or reclaimed water services are initiated to any equivalent residential unit (ERU). The utility deposit and service charge are established by resolution of the City Council.

When establishing services, please bring your driver's license, social security number and proof of ownership (signed warranty deed, settlement statement from the closing or lease agreement).

### REFUNDING OF DEPOSIT

Upon written request, a residential customer, who owns the property, may receive a credit refund in the amount of the utility deposit received after establishment of thirty-six (36) successive months of good credit. Good credit is defined as no service shut off during any successive thirty-six (36) month period. Upon receipt of the written request, by the Finance Department, deposit refund will be applied to the account during the next billing cycle.

ALL OTHER ACCOUNTS. The City will retain the deposit until a request for termination of service is received. At such time, the deposit amount will be applied to the final bill and any amount remaining will be returned to the customer. Deposit refunds are not issued for an amount under \$10.00.

**Pay in person** Payments may be made in person at 104 N. Riverside Drive or by utilizing the Kiosk out front, or the blue payment drop box that is located on the north side of the City Hall building. The City will not be responsible for any cash placed in the drop box.

#### **RATES**

Rates shall be reviewed annually by the City Council to determine if revenues are sufficient to properly operate and maintain the system. The City Council at that time will take official action concerning the utility rates. The current utility rates are available on the City website.

## ALARM PERMITS & REGISTRATIONS

An alarm system is required to be registered within thirty days of the installation/activation date or there will be a \$50 fine. Please notify the City Clerk's Office of any changes to alarm user information.

**Excessive False Alarms** are defined to be more than three false alarms within any six-month period and constitute a serious public nuisance and the alarm user shall be subject to a service charge. ### DOG & CAT LICENSES

Dogs and cats are not allowed to run loose. The City of Edgewater also requires licensing of dogs and cats over the age of four (4) months. The fee for a license is \$15.00 and can be obtained at the Animal Shelter: 605 Mango Tree Drive

Please bring proof of rabies vaccination from your vet with you. Licenses are valid for one year from issue date.

### STEPS TO ADOPT A PET

Are you looking to adopt a pet? First, you may preview pets online. Then, visit the shelter and fall in love. Bring the family and other pets, if you wish, to make certain that you select the best match for everyone.

Finally, complete the Edgewater Animal Services Adoption Application and schedule a home visit. This is a chance for us to see where the pet will be living and an opportunity to discuss pet care. If you already have pets, we may waive the home visit with a positive veterinary reference.

### **Vacation House Watch Program**

Residents simply complete a Vacation House watch form providing needed information to assist in keeping your home safe during your absence. E.P.V.A. members then frequently check the security of your home and report any unusual or criminal activity to the police. The Vacation House watch Program information sheet may be completed either on-line or in the lobby of Edgewater Police Department, 135 E. Park Ave. Citizens may contact Sergeant David Soltz, E.P.V.A. at (386) 409-4791 for further information.

### **Nightly Business Checks**

E.P.V.A. Volunteers patrol area businesses, big and small, for any signs of criminal activity, unsecure doors, etc. If problems are discovered, police assistance is requested and business owners/contacts are notified. Business owners/Operators are requested to contact the E.P.V.A. office with emergency contact information related to their business such as: names, addresses and phone numbers of personnel who can respond to the business should law enforcement request it. Business owners/managers are requested to keep this information current and up to date with our agency by faxing it to the Edgewater Police Department at (386) 424-2431 c/o the E.P.V.A.

### **Wanders Assist Program**

Developed to assist law enforcement in the search and recovery of elderly or endangered residents or visitors who become confused, lost or may have a tendency to "wander" away from home due to some variant of mental incapacity. A photograph of the loved one, as well as pertinent medical and physical identifying information is maintained on our secure agency database. In the event a person in the Wanderers Program

is reported missing or lost information can immediately be accessed and broadcast to all Edgewater Police Officers, E.P.V.A. and other emergency personnel to assist in their speedy and safe recovery. Anyone interested in signing up a family member/loved one can contact the E.P.V.A. at (386) 409-4791 for further information and completion of the information packet.

#### **School Zone/Traffic Management**

Edgewater Police/E.P.V.A. and several volunteer members of the E.P.V.A. conduct traffic management assistance, every school day, twice a day. The E.P.V.A. volunteers provide manpower to assist in the easier and safer flow of traffic at both Indian River Elementary and Edgewater Elementary Schools. In addition to school zone traffic assistance, E.P.V.A. members frequently assist emergency personnel at scenes of traffic accidents, lane closures, obstructions, traffic hazards, etc., again providing extra personnel when it's most greatly needed.

Citizens will frequently see the men and women volunteers of the Edgewater Police/E.P.V.A. at the several area special events such as 4th of July, Christmas Parade, Bike Week, and Biketoberfest events. The extra personnel greatly assist in keeping traffic moving and keeping the streets safer for Edgewater Citizens and visitors.

## Home Solicitation

The City requires anyone soliciting in Edgewater to obtain a solicitors permit from the Volusia County Clerk of Court. Please ask to see this permit before doing any business with them. If the solicitor fails to present a permit, please advise them that they must have a permit and contact the Police Department as soon as possible.

In order to do business as an Itinerant Merchant (i.e. Hot dog cart, pumpkin sales), a permit is required. Further information can be obtained on the City's website or by contacting the City Clerk's office.

## House Numbers

The City requires all buildings to be numbered. The City also requires that 6" numbers be used on new construction. It is the duty of the property owner to obtain and attach said number to building or display it in some conspicuous place on the premises so that it can be seen clearly from the street.

## FIRE & RESCUE COMMUNITY OUTREACH

Edgewater Fire-Rescue is comprised of career and volunteer members who serve our community 24 hours a day, 7 days a week. Fire protection is provided by two staffed fire engines. We provide advanced life support services, including ambulance transport, with paramedics on all of our first response units. Volunteers, fully trained as Florida State Certified Firefighters and Emergency Medical Technicians or Paramedics, supplement our career staff. Support volunteers provide administrative and other services to assist our organization.

Edgewater Fire-Rescue has numerous community outreach programs aimed at all ages and areas of the community. Members are available to check smoke alarms and their batteries. A limited supply of smoke alarms and batteries are available to be installed to those in need of them who cannot afford to purchase them. To schedule a smoke alarm check, please call 424-2400 x2200. Home safety surveys are performed as well to ensure your home is as safe as possible from fire and emergencies.

Routine blood pressure checks are performed at both stations (Station 55 – 1605 South Ridgewood Avenue and Station 57 – 2628 Hibiscus Drive). Residents will be provided with a handy wallet card to track their blood pressure. Wallet size medication cards are also available at each station.

Each year in October, crews visit each of the day care and pre-school centers in the community to share the message of Fire Prevention Week with the children. Throughout the year, units also visit the public and private schools to talk about our jobs, show our equipment and read to students.

Emergency medical technician (EMT) and Paramedic students from Daytona State College ride along on our ambulance as part of their training.

All BTR's and Certificates of Use expire on September 30<sup>th</sup> of each year. While the City does send out courtesy notices several weeks prior to the expiration date, it is the sole responsibility of the Business Owner to ensure that the BTR and Certificate of Use is renewed prior to this date.

## A LITTLE BIT ABOUT OUR HISTORY

As the Civil War was coming to an end, Dr. John Milton Hawks (founder of Hawks Park which later became Edgewater) began looking to the future. When he was granted a furlough from his service to the Union Army, he and his wife (Dr. Esther Hawks) took a trip to Florida to look into purchasing land.

It was during this trip that he found two locations where he would attempt to build new communities – Port Orange and Hawks Park. When his Port Orange development failed, he was determined to make Hawks Park a success. He purchased 500 acres called the Geronimo-Alvarez property which was an old Spanish land grant. He bought it from Charles and Henrietta Lincoln for \$1 per acre. The Lincolns had purchased the land just five days before for only 50 cents per acre.

Dr. Hawks began advertising Hawks Park to northerners looking to relocate. He wrote “The Atlantic coast, is all things considered, the most desirable part of Florida for a residence throughout the whole year....The Ocean breezes are invigorating, and ensure a good appetite, and give rosy cheeks to the children”.
